Hurley Cardiac Rehabilitation – New Location

We are excited to announce that Hurley Cardiac Rehabilitation has moved from its old location at Insight Fitness to its new location on Hurley's Campus, on the ground level. The new space provides cardiac rehab patients a larger and more comfortable environment to receive high quality care from our nursing and exercise physiology staff.

The cardiac rehabilitation program consists of three phases.

PHASE 1					
Inpatient	A gradual progression of activity is offered to help patients return home quickly, while preparing them for the second phase.				
PHASE 2					
Outpatient	Consists of an EKG monitored program, up to 36 sessions. This includes: Blood pressure monitoring; Monitored exercise; Nutrition counseling; Emotional support; and,				
	Education about lifestyle changes to reduce risks of heart disease while strengthening the cardiovascular system.				
PHASE 3					
Maintenance	A self-pay program for those individuals that complete Phase 2 and wish to continue to exercise in the monitored environment to improve their heart health.				

The Cardiac Rehabilitation Facility serves patients who have suffered a heart attack, undergone certain heart procedures, have congestive heart failure and/or other specific heart diseases. Our staff collaborates continuously with the goal of improving quality of life and preventing future hospitalizations.

To begin Cardiac Rehabilitation, a referral from a doctor is required. The patient may call **810.262.2212** for assistance with obtaining a referral or scheduling an initial appointment. Hurley's Cardiac Rehab program is open 9:00 am - 5:00 pm (Monday), and 9:00 am - 4:00 pm (Wednesday and Friday).



Physicians and Mid-Level Providers play a vital role in order reconciliation. Order reconciliation is fraught with the risk of error due to the incomplete or inaccurate communication of crucial patient information. Our team including **Dr. Mercer, Dr. Roebuck**, and **Dr. K. Ahmed** working on improving our order reconciliation for our

patients. In the past 6 months (Oct to Mar) our data shows:
54% of the time we do not reconcile 100% of the prior to admission medications.

• 41% of the time we reconcile 100% of the medications within 24 hours.

Changes to Duration of Antimicrobial Therapy

The new Joint Commission Medication Management standard addressing antimicrobial stewardship is in effect as of January 1, 2017. The purpose of this standard is to slow the emergence of antibiotic-resistant bacteria, detect resistant strains, preserve the efficacy of existing antibiotics, and prevent the spread of resistant infections.

As a result, the Hurley Antimicrobial Stewardship Committee is implementing changes to assure compliance with the new standards. One such change is the initiation of an automatic seven (7) day duration of therapy on all antimicrobials, including antibiotics, antifungals and antivirals. From this point forward, all antimicrobials ordered in EPIC will default to a seven (7) day length of therapy. Exceptions include a five (5) day duration of therapy on oseltamivir (Tamiflu) and azithromycin (Zithromax), and ten (10) day duration of therapy on oral vancomycin. Antiretroviral agents will be excluded.

Prescribers will have the option to modify duration of therapy if clinically indicated. This measure was approved by the Hurley Medical Center Pharmacy and Therapeutics Committee in March, and then the Medical Executive Committee in April.
